

**RESOLUTION #6 OF 2017**

**RESOLUTION OF THE MIDDLETOWN TOWN BOARD ACCEPTING  
PROPOSED LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT  
ESTABLISHED IN GENERAL MUNICIPAL LAW §3-c AND SCHEDULING  
PUBLIC HEARING FOR SAME**

**WHEREAS**, on June 24, 2011 the New York State Legislature enacted Chapter 97 of the NYS Laws of 2011, hereinafter referred to as the “General Municipal Law §3-c”;

**WHEREAS**, General Municipal Law §3-c expressly authorizes local governments to override the tax levy limit by the adoption of a local law approved by a vote of at least sixty percent (60%) of the total voting power of the governing body (in this case, the “Middletown Town Board”);

**WHEREAS**, the Attorney for the Town has prepared a proposed Local Law to Override the Tax Levy Limit established in General Municipal Law §3-c; and

**WHEREAS**, The Town Board has reviewed and modified the proposed Local Law to Override the Tax Levy Limit established in General Municipal Law §3-c; and

**NOW, THEREFORE, BE IT RESOLVED** that the proposed law is ready for consideration by the Town Board; and

**BE IT FURTHER RESOLVED**, that the Town Board shall hold a public hearing for consideration of the Local Law to Override the Tax Levy Limit established in General Municipal Law §3-c on October 12th, 2016 at 6:00 p.m. at the Town Hall; and

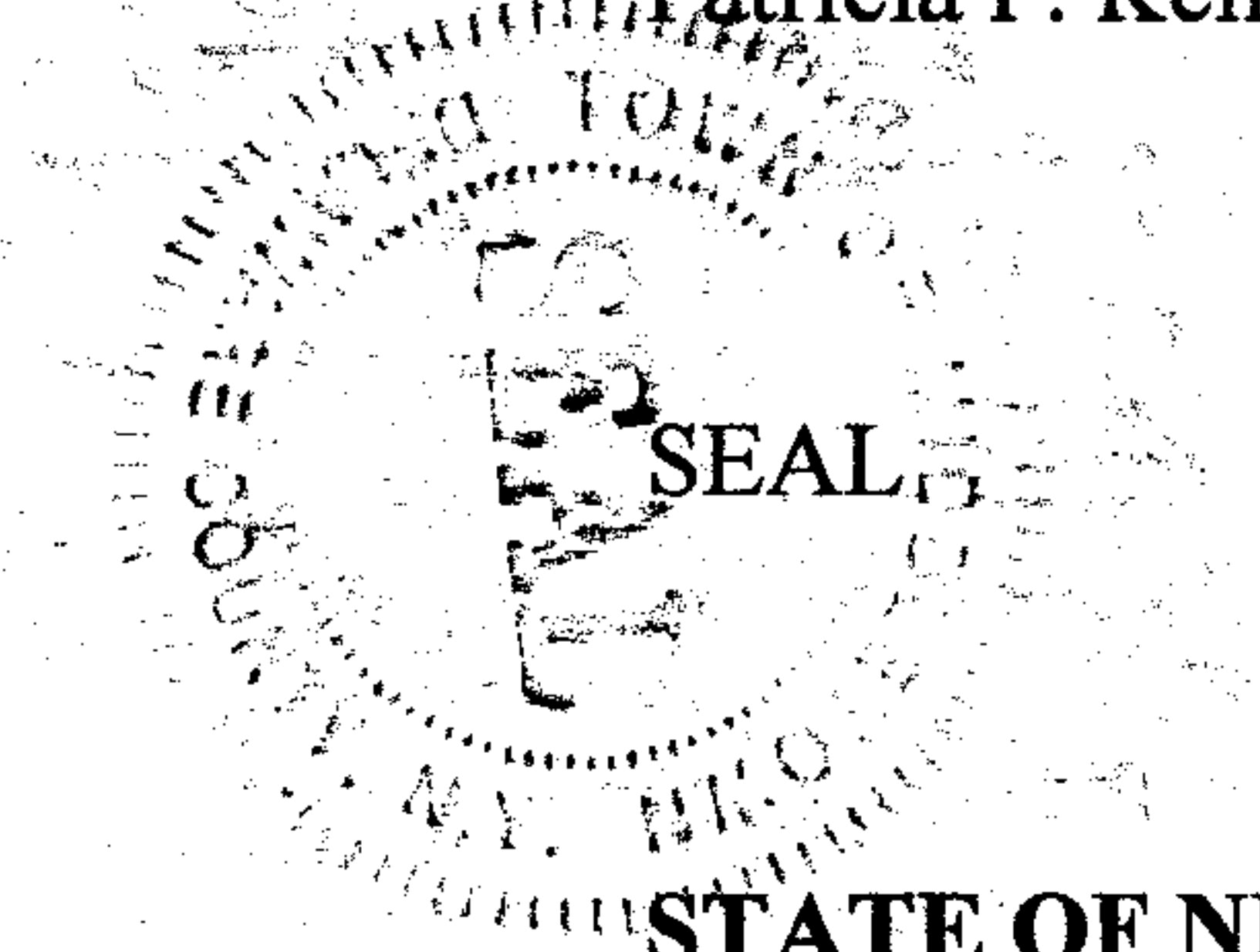
