Nursing Home – add "or other persons".

Make Personal Wireless Telecommunication consistent from definitions to Schedule 1.

Recreation, Commercial – delete "health clubs, reducing salons and tanning parlors".

Recreation, Outdoor - delete "in which no physical alteration to the land owners".

Sawmill/Lumberyard – add and/or after area

Service Establishment – add "health clubs, reducing salons and tanning parlors" and "sales connected to service establishment".

Kennel – add service animals.
