Supervisor Davis called the meeting to order at 6:00 p.m.

Minutes of 05/08/19-Town Board Meeting were approved as submitted, by a motion made by C. Dabritz, seconded by J. Reischel. **(4) Ayes - Carl P. Davis; Kenneth Taylor; Julia Reischel and Christopher Dabritz - (0) Nays.**

Supervisor's Monthly Financial Report for 04/2019; Town Clerk's Monthly Report for 04/2019; Tax Collector-Collection Summary-Batches 64 thru 78 for 04/2019; Building & Zoning Monthly Reports for 04/2019; Justice Court Monthly Reports for 04/2019 and Arkville and Halcottsville Monthly Water Report for 04/2019 were approved as submitted, by a motion made by J. Reischel, seconded by K. Taylor. **(4) Ayes - Carl P. Davis; Kenneth Taylor; Julia Reischel and Christopher Dabritz - (0) Nays.**

The Town Board reviewed the ATTACHED Arkville-Halcottsville Water Monthly Action Report for May 2019 prepared by Bob Payne.

Supervisor Davis opened the floor to the public. Anne Sanford, Sharon Suess, Jenny Liddle and Donald McPherson reviewed their concerns with "No Parking" signs on both sides of the road in Halcottsville with the Town Board. The Town Board agreed to remove the signs on the north side of the road from April 15th through November 15th but put the signs back up from November 16th through April 14th, which would be the same schedule as seasonal roads, for snow removal. Steve Finkel reviewed the ATTACHED Memo which he prepared with the Town Board concerning the potential septic system to be installed in New Kingston and asked "That the voting date be re-scheduled so clear instructions can be sent out along with sufficient absentee ballot request forms and enough time for this vote to be legal and fair".

Motion was made C.P. Davis, seconded by K. Taylor to re-appoint Joyce Gray to the Planning Board for the term 08/01/19-07/31/26. **(4) Ayes - Carl P. Davis; Kenneth Taylor; Julia Reischel and Christopher Dabritz - (0) Nays.**

The monthly vouchers were audited and ordered paid by a motion made by K. Taylor, seconded by J. Reischel. **(4) Ayes - Carl P. Davis; Kenneth Taylor; Julia Reischel and Christopher Dabritz - (0) Nays.** Vouchers approved were #s 312-365, totaling \$142,294.35.

Motion for adjournment was made by C.P. Davis, seconded by K. Taylor. **(4) Ayes - Carl P. Davis; Kenneth Taylor; Julia Reischel and Christopher Dabritz - (0) Nays.** The meeting was adjourned at 7:40 p.m.
