RESOLUTION #1 of 2021 RESOLUTION RECOMMENDING THE APPOINTMENT BY THE GOVERNOR OF A SECOND VICE-CHAIR TO THE BOARD OF DIRECTORS OF THE OLYMPIC

REGIONAL DEVELOPMENT AUTHORITY

At a meeting of the Town Board of the Town of Middletown, the Town Supervisor offered the following resolution:

WHEREAS, Belleayre Mountain Ski Center is located in the Towns of Shandaken and Middletown in Ulster and Delaware Counties, respectively; and

WHEREAS, Belleayre Mountain Ski Center is managed and operated by the State of New York Olympic Regional Development Authority (ORDA); and

WHEREAS, among other things Public Authorities Law § 2608 (1) and the ORDA By-Laws provide that:

> ORDA is a public benefit corporation, the Board of Directors of which shall consist of twelve members, three of whom consist of the commissioners of environmental conservation, economic development, and parks, recreation, and historic preservation, and the other nine of whom are to be appointed by the Governor, by and with the advice and consent of the senate; and

> Two of those board members shall be residents of Ulster and Delaware Counties; and

The governor shall appoint a chairperson, a vice-chairperson and a second vicechairperson from among any of the members of the authority and such chairperson, vice-chairperson, and second vice-chairperson shall serve at the pleasure of the governor; and

Provided that the Second Vice-Chairperson of the ORDA Board of Directors shall be appointed upon the recommendation of the town boards of the town of Shandaken and the town of Middletown, and must be a resident of either Ulster County or Delaware County; and

Such appointment shall be recommended to the governor through a majority vote of the combined two town boards determining who shall be recommended; and

WHEREAS, among other responsibilities, it will be the responsibility of the Second Vice-Chairperson to Chair any meeting of the ORDA Board of Directors in the event that the Chairperson and Vice-Chairperson are absent, recused, or unavailable for any other reason; and

WHEREAS, the ORDA Board of Directors does not currently have a Second Vice-Chairperson;

NOW THEREFORE BE IT RESOLVED, that after careful consideration and due deliberation, by a majority vote, the Town Board of the Town of Middletown has determined that Diane Munro, who was appointed by the Governor to the ORDA Board of Directors on or about July 23, 2020 and who is a resident of Delaware County, shall be recommended to the Governor for appointment to the position of Second Vice-Chairperson for the ORDA Board of Directors.
