

**RESOLUTION # 14 OF 2021**  
**A RESOLUTION CONCERNING PARKING SIGNS**  
**ON STATE HIGHWAY 28 AND CHURCH STREET**  
**IN ARKVILLE**

**WHEREAS**, State Route 28 is a New York State maintained road; and

**WHEREAS**, parked cars near the intersection of State Highway 28 and Church Street, Arkville create a hazard by blocking visibility of oncoming traffic; and

**WHEREAS**, by Resolution No.10 of 2021, the Town Board of the Town of Middletown requested that the State of New York Department of Transportation install “No Overnight Parking” and “Two Hour Parking between 7 am and 7 pm”; and

**WHEREAS**, after additional public input concerning parking along the affected portion of State Route 28 the Town Board desires to revise its request to the New York State Department of Transportation and otherwise amend its plan for addressing traffic issues at the intersection of State Highway 28 and Church Street;

**NOW, BE IT RESOLVED** by the Town Board of the Town of Middletown, Delaware County, New York, as follows:

**RESOLVED**, that Resolution No. 10 of 2021 is hereby withdrawn; and it is further

**RESOLVED** the Town of Middletown requests the State of New York Department of Transportation to install signs regulating parking along the northern side of Route 28, beginning approximately 560 feet East of its intersection with County Route 38. From that starting point going West for 170 feet, such signs shall read “No Parking At Any Time”. The remaining 390 feet going West shall have signs stating “No Overnight Parking” and “Two Hour Parking between 7 am and 7 pm”.

The number and frequency of such signs shall be determined by the New York State Department of Transportation.



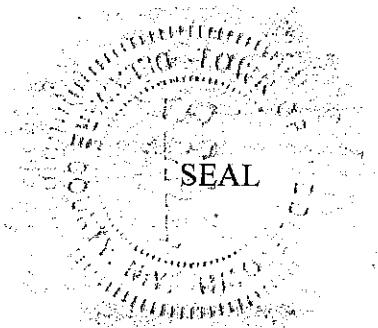
Councilperson Christopher Dabritz was not in attendance.


