

RESOLUTION #16 OF 2021

A RESOLUTION ADOPTING LOCAL LAW NO. 1 OF 2021 - A LOCAL LAW TO ESTABLISH THE RESIDENCY REQUIREMENTS FOR THE APPOINTED OFFICE OF DEPUTY HIGHWAY SUPERINTENDENT OF THE TOWN OF MIDDLETOWN

WHEREAS, the Town Board has reviewed and considered the proposed Local Law; and

WHEREAS, the Local Law was presented to the Town Board at least 10 days prior to the Town Boarding Meeting on May 12th, 2021; and

WHEREAS, the Public Hearing was properly noticed in the Town's official newspaper on April 30th, 2021; and

WHEREAS, the Public Hearing on the proposed Local Law No. 1 of 2021 was held on May 12th, 2021 at 6:00 P.M. at the Town Hall; and

WHEREAS, the Town Board reviewed and considered all public comments received on the proposed Local Law; and

WHEREAS, the proposed Local Law was on file for inspection at the Town Clerk's Office prior to the hearing and during the public review process:

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS BY THE TOWN BOARD OF MIDDLETOWN, DELAWARE COUNTY, NEW YORK:

THAT THE Town Board of the Town of Middletown hereby determines that the proposed Local Law attached hereto and made a part hereof, is hereby adopted as a Local Law No. 1 of 2021 entitled "A Local Law to Establish the Residency Requirements for the Appointed Office of Deputy Superintendent of the Town of Middletown; and

IT IS FURTHER RESOLVED, that the Town Clerk is hereby directed to take such actions as are necessary to implement this resolution and effect adoption of the Local Law.

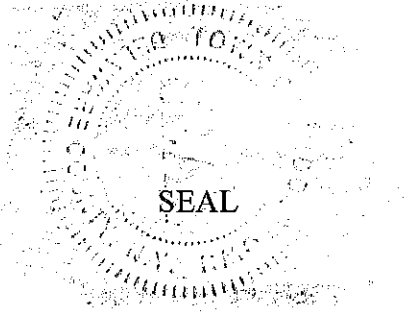
