**A RESOLUTION ADOPTING LOCAL LAW NO. 2 OF 2021 - A LOCAL LAW CONCERNING THE PERMITTED USE OF THE TOWN OF MIDDLETOWN TRANSFER STATION REPLACING LOCAL LAW NO. 6 OF 2012**

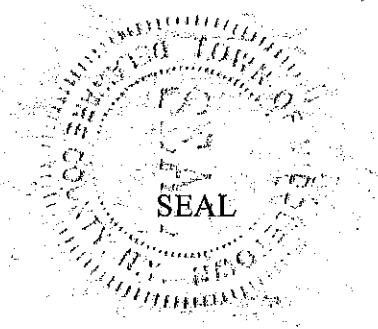
