A RESOLUTION AUTHORIZING THE REFILING OF THE NEW KINGSTON SEWER USE LAW (Local Law No. 1 of 2019) AS LOCAL LAW NO. 3 OF 2021

WHEREAS, by Resolution #13 of 2019, in connection with the Project, the Town adopted Local Law No. 1 of 2019 - a Sewer Use Law governing the use of and connection to the Town's Community Wastewater Treatment System ("SUL"). The New Kingston Sewer District SUL also includes a Sewer Rent Law specifying the sewer rate structure and a Sewer Allocation Law defining the procedure for the Town Board to make decisions regarding future connections to the sewer system; and

WHEREAS, on May 30, 2019, the Town filed the SUL with the Office of the Secretary of State ("SOS") in accordance with State Law; and

WHEREAS, on July 2, 2019, by request of the SOS, the Town submitted a revised local law filing form and copies of the SUL to the SOS for filing; and

WHEREAS, it has come to the attention of the Town that the SUL has not been recorded with the SOS; and

WHEREAS, the Town desires to resubmit the SUL to the SOS for successful recording; and

WHEREAS, upon information from the SOS, the Town must rename Local Law No. 1 of 2019 as a local law in the current calendar year; and

NOW BE IT RESOLVED:

- 1. The Town Board has previously determined that the Sewer Use Law, Sewer Rent Law and the Sewer Allocation Law will not have a significant impact on the environment and are consistent with the prior SEQRA findings for this project; and
- 2. That Sewer Use Law (which incorporates the Sewer Rent Law and Sewer Allocation Law), previously entitled Local Law No. 1 of 2019, is hereby renamed as Local Law No. 3 of 2021, and the Town Clerk is hereby directed to file said Local Law with the Office of the Secretary of State in accordance with State Law.
