RESOLUTION #1 of 2023 RESOLUTION FOR AMENDMENT TO THE INCOME LEVEL IN RELATION TO THE PARTIAL TAX EXEMPTION FOR PERSONS 65 YEARS OF AGE OR MORE

WHEREAS, the existing income ceiling of \$23,500.00 for the real property tax exemption for persons 65 years and older in the Town of Middletown is no longer effective in protecting the most vulnerable of the Town's citizens; and

WHEREAS, the Town Board has determined that it is in the public interest to increase said income ceiling, thereby providing partial real property tax exemptions to a larger number of senior citizens in need of tax relief.

NOW, THEREFORE, BE IT RESOLVED, that all previous Resolutions in regard to "TAX EXEMPTIONS FOR PERSONS 65 YEARS OF AGE AND OVER" are HEREBY rescinded and the following to be adopted for granting Real Property Tax Exemption for persons 65 or order in the Town of Middletown:

BE IT RESOLVED, that the applicant must show that they have owned their property for the past 12 consecutive months prior to filing for the exemption, that it is the legal residence of and occupied in whole or in part by the owner or by all of the owners, and that the property is used exclusively for residential purposes, provided, however, that in the event any portion of such property is not used exclusively for residential purposes but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption; and the tax exemption for real property owned by husband and wife, one of whom is sixty-five years of age or over, once granted, shall not be rescinded solely because of the death of the older spouse so long as the surviving spouse is at least sixty-two years of age.

BE IT RESOLVED, that pursuant to the authority granted by Section 467 of the Real Property Tax Law, real property within the Town of Middletown owed by one or more persons, each of whom is 65 years of age or over, or real property within the Town of Middletown owned by husband and wife, one of whom is 65 years of age or over, shall be exempt from Town of Middletown tax levy according to the following schedule based on income of the owner or combined income of the owners of the property for the tax year immediately preceding the date of application:

Income of \$17,000.00 or less	50% reduction
Income of \$17,000.01 or more but less than \$17,999.99	45% reduction
Income of \$18,000.00 or more but less than \$18,999.99	40% reduction
Income of \$19,000.00 or more but less than \$19,999.99	35% reduction
Income of \$20,000.00 or more but less than \$20,899.99	30% reduction
Income of \$20,900.00 or more but less than \$21,799.99	25% reduction
Income of \$21,800.00 or more but less than \$22,699,99	20% reduction
Income of \$22,700.00 or more but less than \$23,599.99	15% reduction
Income of \$23,600.00 or more but less than \$24,499.99	
Income of \$24,500.00 or more but less than \$25,399.99	

BE IT FURTHER RESOLVED that all the provisions of Section 467 of the Real Property Tax Law shall apply in the administration and interpretation of this Resolution and such exemption shall not be granted unless the applicant qualified thereunder; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.
