A RESOLUTION AUTHORIZING THE EXECUTION OF A NYSEG UTILITY EASEMENT IN CONNECTION WITH THE CONSTRUCTION AND OPERATION OF THE NEW KINGSTON SEWER PROJECT

WHEREAS, the Town Board of the Town of Middletown ("Town") previously entered into an agreement with the Catskill Watershed Corporation to participate in the Community Wastewater Management Program, which program will provide for the design and construction of a wastewater management project in the Hamlet of New Kingston ("Project"); and

WHEREAS, the Project is currently under construction in the Hamlet of New Kingston, and the Town must grant New York State Electric & Gas ("NYSEG") an easement and right of way 10 x 10 feet in width to install, maintain and repair and/or replace a PAD mounted transformer on Town-owned property identified as Tax Parcel Section 241 Block 1 Lot 1.12; and

WHEREAS, the Town Board and the Town's special counsel has reviewed the proposed easement prepared by NYSEG which is incorporated by reference herein.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Middletown hereby approves the form and substance of the NYSEG Easement and authorizes and directs the Town Supervisor, for and on behalf of the Town, to execute and deliver the Easement to NYSEG for recording with the Delaware County Clerk and authorizes and directs the proper officials, agents and employees of the Town to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Town in accordance with the provisions of the Easement.
