## **RESOLUTION #16 OF 2022**

## A RESOLUTION REGARDING WATER SERVICE CHARGES FOR THE HALCOTTSVILLE WATER DISTRICT

The Town Board of the Town of Middletown in regular session duly convened does hereby resolve as follows:

WHEREAS, service charges within the Halcottsville Water District related to water shutoffs, reconnections and replacement of frozen or broken water meters have not been updated in several years; and

WHEREAS, the Town Board of the Town of Middletown has determined that said service charges require updating; and

WHEREAS, The Town Board, after due consideration, has agreed upon a new fee schedule for said service charges, and finds that said charges are reasonably related to the actual costs of providing such services.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Middletown does hereby adopt new service charges for the Halcottsville Water District as follows:

a	Penalty for Water Bills Delinquent after 30 days	10% per month of last billing
9	Water Shutoff Charge – Weekdays	\$100.00
9	Water Shutoff Charge – Weekends	\$200.00
•	Water Turn On Charge – Weekdays	\$100.00
	Water Turn On Charge – Weekends	\$200.00
•	Replace Non-Working Meter	\$0.00
•	Repair/Replace Frozen Meter – Weekdays*	\$250.00
•	Repair/Replace Frozen Meter – Weekends*	\$350.00
•	Customer Requesting Meter Change**	\$250.00
•	Reconnect Fee After Shutoff for Nonpayment	\$50.00

<sup>\*\$100.00</sup> per re-occurrence in that season

ACCOUNTS MUST BE PAID IN FULL PRIOR TO PLACING IN ANOTHER NAME AND METER READ REQUESTS MUST HAVE A 3-5 BUSINESS DAY LEAD TIME.

If accounts are more than 90 days overdue service will be discontinued and the water supply will be shut off until arrears, penalty and re-connect fee are paid in full.

AND BE IT FURTHER RESOLVED, that said new service charges will become effective as of August 10<sup>th</sup>, 2022;

AND BE IT FURTHER RESOLVED, that all other water rates for the Halcottsville Water District shall remain the same.

<sup>\*\*</sup>If meter is found to be inaccurate customer will not be charged
