**NOW THEREFORE BE IT RESOLVED**, that the Town of Middletown Town Board established a "Liaison" assignment to the Margaretville Hospital Board of Directors; and be it further

**RESOLVED**, that the Town Clerk is hereby directed to file a signed, sealed copy of this resolution with Michael Doyle MD, Executive Director and Chief Medical Officer, Health Alliance Hospital along with a letter requesting an immediate response, and be it further

**RESOLVED**, that this Resolution shall take effect immediately.

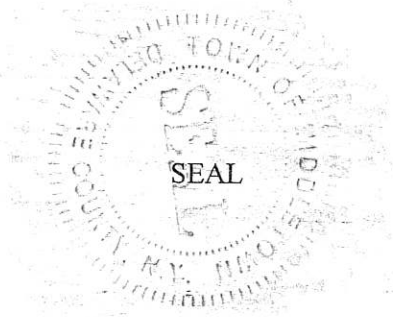
