## **RESOLUTION NO. 9 OF 2023**

## RESOLUTION AUTHORIZING THE TOWN TO ACCEPT OPERATING AGREEMENT FOR THE NEW KINGSTON SEWER DISTRICT

WHEREAS, the Town of Middletown ("the Town") is undertaking the construction of a community septic system to provide sewer service to parcels within the New Kingston Sewer District (the "Sewer District"); and

WHEREAS, the New York City Department of Environmental Protection ("NYCDEP") will issue a Certificate of Functional Completion when the community septic system for the Sewer District has been deemed complete and operational; and

**WHEREAS**, the Town will be responsible for the operation and maintenance of the community septic system for the Sewer District once NYCDEP has issued the Certificate of Functional Completion; and

WHEREAS, the Town has received a proposal from LVDV Operations, Inc., dated July 20, 2023 (the "Proposal"), to provide professional contract operator services for the New Kingston Sewer District; and

WHEREAS, the Town Supervisor has requested that the New Kingston Sewer District attorney (the "Sewer Attorney") prepare an agreement (the "Operating Agreement") consistent with the terms and conditions of the New Kingston Operation and Maintenance Agreement with NYCDEP for the retention of LVDV Operations, Inc to operate the sewer system consistent with the terms of the Proposal.

**NOW, THEREFORE, BE IT RESOLVED** that the Town Supervisor is authorized to execute, on behalf of the Town, the Operating Agreement for contract operator services for the New Kingston Sewer District prepared by the Sewer Attorney.
